EASEMENT

This indenture made this 25 day of June 2007, by and between, Kevin Rice and Lori Rice, Husband and Wife, hereinafter referred to as "Grantor", and all present and future owners of Lots 3, 5, 6, 7, 8, 9, 10 and 11 in Cornish Acres, a subdivision as surveyed, platted and recorded in Sarpy County, Nebraska and their guests, invitees and such other persons as may from time to time lawfully use the easement described herein, hereinafter collectively referred to as "Grantee", to-wit:

WITNESSETH:

That Grantor in consideration of the sum of One Dollar (\$1.00) and other valuable consideration, does hereby grant and convey to Grantee to the extent of any interest Grantor has therein, a perpetual non-exclusive ingress and egress easement over and across the following described real estate:

That part of Lot 4, Cornish Acres, a subdivision in Sarpy County, Nebraska, described as follows: beginning at the SW corner of said Lot 4; thence N 00°04'56"W (Assumed Bearing) 50.00 feet on the West line of said Lot 4; thence Southeasterly on a 50.00 foot radius curve to the right, chord bearing S 45°09'12"E, chord distance 70.62 feet, an arc distance of 78.41 feet to the South line of said Lot 4; thence S 89°46'32"W 50.00 on the South line of said Lot 4 to the point of beginning

Said easement is depicted on the survey attached hereto as Exhibit "A".

To have to hold said Easement and right-of-way unto said Grantee, their successors and assigns, and to all present and future owners of Lots 3, 5, 6, 7, 8, 9, 10 and 11 in Cornish Acres, a subdivision as surveyed, platted and recorded in Sarpy County, Nebraska and their guests, invitees and such other persons as may from time to time lawfully use the easement described herein in perpetuity.

Said easement to run with the land and shall be binding upon the heirs, successors and assigns of Grantee.

IN WITNESS WHEREOF, the Grantors have caused this easement to be signed on the day and year first above written.

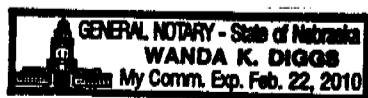

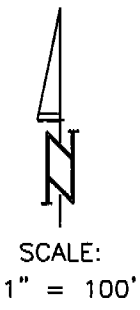
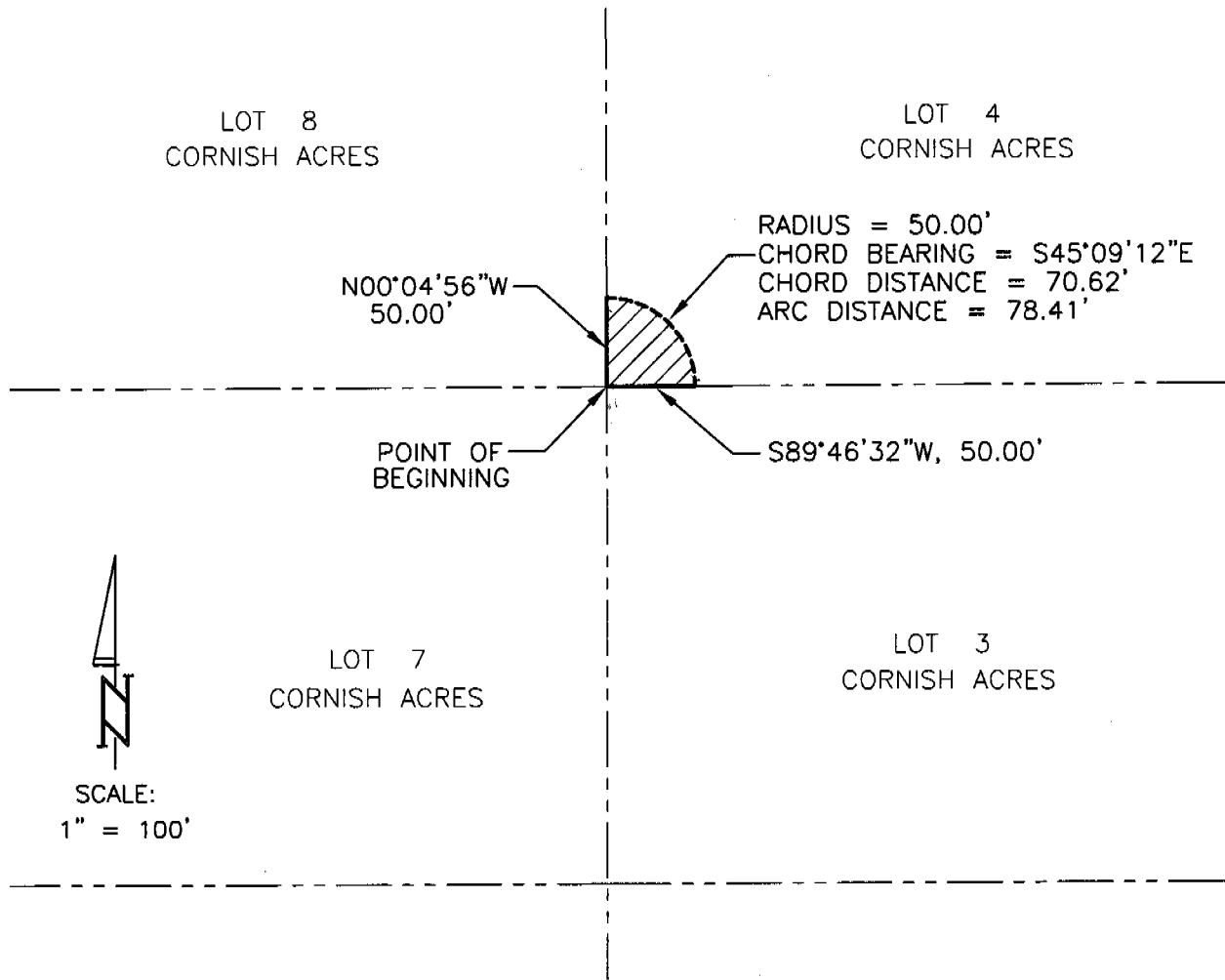
