Student, Rahman Strum, will be completing a minority needs assessment for the Department for his Capstone Project Course. Kelly passed out Rahman's project proposal.

In honor of April being Public Health Month, the SCDHW Environmental Health Coordinator, Jenny Steventon held a plastic bag recycling drive at Westmont Elementary School and Springfield Elementary. The total number of bags collected from both schools was 41,346.

Cindy Ossino, the School & Family Health Coordinator, is on the planning committee for the Nebraska Action for Health Kids Summit. Cindy's name and the Department name were both mentioned in the program as sponsors.

Monica Ulses, Public Health Nurse, investigated a small e-coli outbreak as well as a pertussis outbreak. Kelly added that she received an email from Dr. Safranek saying how much he enjoys working with the Sarpy/Cass Department of Health and how all cases are handled immediately.
