BOH Director's Report

July 24, 2017 (Reporting Period May 2017 – June 2017)

- NALHD hosted a meeting with 17 health directors and DHHS Public Health Division senior administrators, auditor and attorney to discuss LHDs concerns related to contracts and grants. A follow-up meeting is scheduled on July 21st.
- Attended a presentation on the State of Sarpy County. Commissioner Kelly gave a summary at the last BOH meeting.
- Participated in a 2-day Nebraska Health Policy Short Course sponsored by UNMC College
 of Public Health. Objectives for the course: Understanding the components of the policy
 making process; Identify tools used to choose the most effective policy solutions;
 Explore individual and collaborative efforts for influencing the policy making process;
 Discuss best practices for effective health policy.
- Gbadero Yerokun and I attended a presentation on the Community Health Endowment of Lincoln Place Matters Community Mapping Project to learn how to collect data, make it visual, look for patterns and draw conclusions.
- Jenny Steventon, Gbadero Yerokun, Arlene Williams and I attended the 1st Annual Nebraska Chronic Disease Summit in LaVista. The summit featured national, state and local speakers highlighting current efforts toward preventing and controlling heart disease, diabetes and obesity.
- Attended a workshop sponsored by the Nonprofit Association of the Midlands "Be Bold! The Legal Rules for Advocacy that Every Non-Profit Should Know". The workshop provided a clear understanding of how to maximize advocacy, the kinds of advocacy activities 501 (c)(3)s can engage in, when a communication is considered lobbying, best practices for talking to funders about advocacy, and how to remain nonpartisan while engaging in election-related activities.
- Staff conducted a Nutrition Environment Measures Survey assessment of retail food outlets to observe access to healthy foods in Sarpy County. The assessment was funded by the Iowa West Foundation in partnership with United Way of the Midlands, NE Grocery Industry Association and SCHD.

<u>Legislative /County Update</u>

Tobacco Free Cass County announced that both Greenwood and Elmwood Village
Boards passed tobacco free park resolutions this year. This makes 3 villages within Cass
County that now have a tobacco-free park policy. The Village of Louisville was the first to
enact a tobacco-free policy that went into effect in November of 2010. (Attachment 1)

Personnel/Policy/Department Changes

- Health Director resigned, effective August 31, 2017.
- Gbadero Yerokun was accepted into the Great Plains Leadership Institute. It is a yearlong competency based training program designed for established and emerging leaders in organizations whose primary mission is to improve the health and well-being of populations and communities.

Financial Updates

- Explored funding options with Brenda Carlisle through two foundations, Midlands Community Foundation and Lift Up Sarpy. (Attachment 2)
- Awarded \$4,940.00 Susan G. Komen grant to increase breast cancer screening for rural, minority, and refugee women aged 50-75 residing in Sarpy and Cass counties by providing transportation assistance to and from screening appointments for 45 women enrolled in the *Every Woman Matters* program.
- Awarded \$5,950.00 for the Making Connections Grant to continue outreach to veterans and their families.
- Received a total of \$600.00 in donations for the Safe Kids Program:
 - > \$500.00 Plattsmouth Lions Club
 - > \$100.00 Bellevue Cars of Bellevue
- Applied for funding (up to \$100,00) Phase I from the Aetna Foundation Cultivating
 Healthy Communities grant to support activities to prevent and reduce exposures to
 environmental health hazards through enhanced surveillance, testing, and public
 awareness campaigns. Not selected to move forward to Phase II.

March	EHS completed inspections of indoor swimming pools in Sarpy County, as well as
	partnered with DHHS Swimming Pool Program staff to offer one swimming pool
	operator training. A Zika, Dengue, and Chikungunya response plan was finalized and
	submitted to DHHS.
