Director's Report:

Lausterer reported the following:

Results received from the Nebraska Behavioral Risk Factor Surveillance System 2014. Lausterer will send out data to anyone interested.

Dr. Kahn, Dean, College of Public Health at UNMC and Brandon Grimm, Director, Office of Public Health Practice, will visit the department on December 10th from 1-2 p.m. Ruth Cover and John Sheehan will attend. Lausterer would like all BOH members to join if they are able.

Dale Tedder and Monica Ulses attended an exercise put on by the CDC at the Nebraska Poison Center. The flu on-call system was being tested. There they found out that Walgreens and the US Department of Health and Human Services are partnering to offer vouchers for free influenza vaccines for those who are uninsured or underinsured adults. We did receive 10 vouchers.

The Inter-Cultural Center was interested hosting a foot care clinic. Lausterer did discuss this with the Dr. Pour, Director, Douglas County Health Department because the location is in their jurisdiction. Dr. Pour gave her full support for SCDHW to provide this service not only at the Inter-Cultural Center, but any other location in Douglas County.

Jenny Steventon and Monica Ulses both celebrated 10 years of service. Jane Husz resigned from her position as the Safe Kids Coordinator.

The position for a Public Health Nurse will be open. This position will provide assistance to Ulses with disease investigations. This position would also take over school surveillance and possibly help with the foot care clinic. It would benefit the department to hire a full time health educator to coordinate the Safe Kids program and also help with data analysis.

We have contracted with our current payroll company, PayrollMaxx to create a new electronic timekeeping system.

Lausterer discussed with the BOH the option for her to change the verbiage in the personnel manual in order to update policies accordingly.

Warsing moved, seconded by Dr. Neumann to allow Lausterer the authority to change the policies as needed and update the personnel committee on any changes.
